Module 1: How to Define My Professional Objective

The content of Module 1 was highly praised for its clarity, structure, and practical applicability to daily life and work. Participants found the module's objectives well-defined, providing them with useful knowledge that aligns with their expectations. The module's structure allows learners to engage deeply with the material, and it effectively guides them through the process of defining their professional goals. Despite the overall positive feedback, some responses suggested that the module could benefit from a greater emphasis on green competencies, which could further enhance its relevance to current job market trends. Regarding the E-learning platform, participants highlighted its user-friendliness, appealing visual design, and the effectiveness of the final assessments, which consolidate the key learning points in an accessible manner. Learners expressed high levels of satisfaction, noting the motivational aspects of the content and the simplicity of the language used, making the material approachable. However, some felt that the assessment questions could be improved by avoiding repetition and providing more

challenging exercises to deepen understanding. Additional comments reaffirmed the overall positive perception of the module, with no significant suggestions for changes, reflecting a high level of satisfaction among participants.

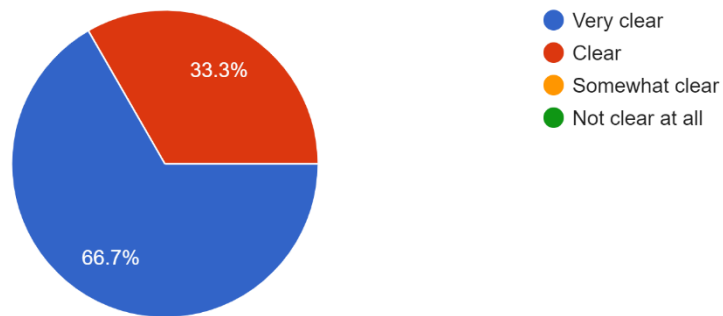

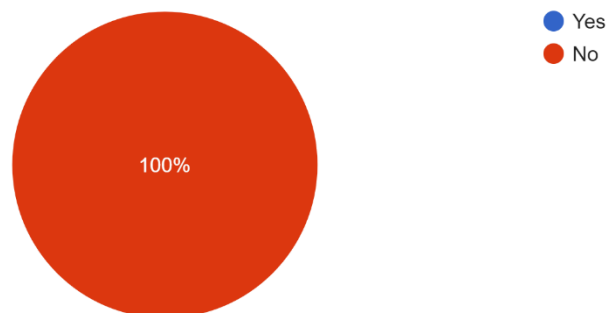
